**DEBTORS' MOTION TO REJECT CERTAIN SITE LEASES  
EFFECTIVE AS OF THE PETITION DATE**

The above-captioned debtors and debtors in possession (collectively, the "Debtors"),<sup>1</sup> for their Motion to Reject Certain Site Leases Effective As Of The Petition Date (the "Motion"), respectfully represent:

**JURISDICTION AND VENUE**

1. The Court has jurisdiction over this Motion pursuant to 28 U.S.C. §§ 157 and 1334. This matter is a core proceeding pursuant to 28 U.S.C. § 157(b)(2)(A) and (O)
2. Venue in this Court is proper pursuant to 28 U.S.C. §§ 1408 and 1409.

### **INTRODUCTION**

3. On July 17, 2012 (the “Petition Date”), each of the Debtors filed with this Court petitions for relief under chapter 11 of title 11 of the United States Code (the “Bankruptcy Code”).

4. The Debtors are operating their businesses and managing their properties as debtors in possession, pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.

### **BACKGROUND**

5. The Debtors are an alternative provider of facilities-based backhaul services, principally to wireless carriers, and a national provider of millimeter-band spectrum services. Backhaul is the transport of voice, video and data traffic from a wireless carrier’s mobile base station, or cell site, to its mobile switching center or other exchange point. The Debtors offer these backhaul services nationally by utilizing wireless spectrum assets and fiber relationships to construct and operate high-coverage, high-capacity hybrid microwave and fiber networks. The Debtors provide spectrum leasing services directly to other carriers and enterprise clients, and also offer their spectrum services through spectrum brokerage arrangements and through fixed wireless equipment partners. A significant asset of the Debtors is their ownership of a national spectrum portfolio (the “Spectrum Portfolio”) of 24 GHz and 39 GHz wide-area spectrum licenses, including over 740 MHz in the top twenty (20) U.S. metropolitan areas and, in the aggregate, approximately 1.72 billion channel pops (calculated as the number of channels in a given area multiplied by the population, as measured in the 2010 census, covered by these channels).<sup>2</sup> The Debtors believe that the Spectrum Portfolio represents one of the largest and

most comprehensive collections of millimeter wave spectrum in the U.S., covering areas with a total population of over 300 million.

6. As of the Petition Date, the Debtors provide service to approximately 5,390 customer locations at approximately 3,188 deployed sites in thirteen (13) markets throughout the U.S. The fixed wireless portion of these hybrid services is predominantly through common carrier spectrum in the 11, 18 and 23 GHz bands. The Debtors' biggest service markets are Dallas/Fort Worth and Washington, D.C./Baltimore, with additional markets in Atlanta, Boston, Chicago, Cleveland, Denver, Detroit, Houston, New York/New Jersey, Pittsburgh, San Antonio/Austin/Waco and Tampa.

7. The Debtors have customer service agreements with major U.S. wireless carriers. The Debtors also hold separate national-scope service agreements with Verizon Business and CenturyLink which allow them to provide government grade transport services to the United States General Services Administration and other governmental entities.

8. In connection with their business, the Debtors have entered into, and are thus parties to, many site leases, where the Debtors install and maintain equipment to provide their backhaul services. Some of these leases are "one off" stand-alone leases. Other leases, often denominated as "site license agreements" ("SLAs") or "licenses" among other names (globally referred to herein as "SLAs" for ease), were entered into under, and are subject to the global and generally applicable provisions of, one of several "master" lease agreements (collectively, "MLAs"), with each SLA having specific terms pertaining to a specific location, but also being governed by the generally applicable provisions of its MLA. Each SLA is subject to being independently assumed or rejected.

9. The Debtors have determined, in their business judgment, that approximately 238 leases and/or SLAs (collectively, the “Leases”) are no longer necessary to their business operations, are consuming otherwise scarce resources, and will not be required as part of their overall restructuring. As a result, the Debtors seek to reject the Leases (as set forth on the attached Exhibit “A”), with such rejection effective as of the Petition Date.

### **RELIEF REQUESTED**

10. By this Motion, pursuant to section 365(a) of the Bankruptcy Code, the Debtors seek entry of an order authorizing rejection of the Leases appearing on the attached Exhibit “A,” with such rejection being effective as of the Petition Date.<sup>3</sup>

### **ARGUMENT AND AUTHORITY**

11. Section 365(a) of the Bankruptcy Code, which governs the rejection of unexpired leases and executory contracts, provides in pertinent part, that:

the trustee, subject to the court’s approval, may assume or reject any executory contract or unexpired lease of the Debtors.

11 U.S.C. § 365(a).

12. The business judgment standard governs the Debtors’ decision to reject the Leases. *See Richmond Leasing Co. v. Capital Bank, N.A.*, 762 F.2d 1303,1308 (5th Cir. 1985) (“It is well established that ‘the question whether a lease should be rejected . . . is one of business judgment.’”); *In re Texas Sheet Metals, Inc.*, 90 B.R. 260, 2641 (Bankr. S.D. Tex. 1988) (“The traditional business judgment standard governs the rejection of ordinary executory contracts.”). Rejection should be permitted if, in the Debtors’ exercise of their business judgment, the Leases

The Debtors reserve all rights with respect to any and all claims for rejection damages which may be filed including, but not limited to, contending that no damages are owing as a result of a prepetition Lease termination.

are burdensome to the estate such that the rejection of the Leases will benefit the estate. *In re Minges*, 602 F.2d 38, 43 (2d Cir. 1979).

13. Here, the Debtors seek to reject approximately 238 Leases. In the aggregate, the monthly rent payable under such Leases is approximately \$47,000. Maintaining the Leases on a go-forward basis constitutes an unnecessary cost to the Debtor and their respective estates, given that the Debtors have decided that the Leases are not necessary to their reorganization. Continuing the Leases will, therefore, burden the Debtors' estates. Instead, by rejecting the Leases, the Debtors will have additional funds available each month to be used to fund the reorganization. Rejection of the Leases will, therefore, benefit the Debtors and their respective estates and creditors.

14. Counterparties to certain MLAs may contend that the MLA in question is not severable from the underlying SLAs and, thus, that individual SLAs cannot be assumed or rejected without assuming or rejecting the MLA itself. However, it is well established in this Circuit, and others, that agreements may be severable, or divisible, into smaller component agreements, with each smaller component being independently subject to assumption or rejection. *See generally Stewart Title Guar. Co. v. Old Republic Nat'l Title Ins. Co.*, 83 F.3d 735, 741-42 (5th Cir. 1996); *In re Gardinier, Inc.*, 831 F.2d 974, (11th Cir. 1987); *see also In re Convenience USA, Inc.*, No. 01-81478, 2002 WL 230772 (Bankr. M.D.N.C. Feb. 12, 2002); *In re Holly's, Inc.*, 140 B.R. 643, 681 (Bankr. E.D. Mich. 1992); *In re Cutters, Inc.*, 104 B.R. 886, 889 (Bankr. M.D. Tenn. 1989). Whether an agreement is severable is a matter of state law and often times (if not all of the time) the intent of the parties. *In re Mirant Corp.*, 318 B.R. 100, 105-106 (N.D. Tex. 2004) (deciding issue under law of District of Columbia).

15. The MLAs are arguably controlled by various state laws. However, a review of the various provisions of the MLAs shows that the underlying SLAs are severable and may, thus, be assumed or rejected separate and apart from the MLA itself. Courts have recognized that individual agreements entered into under a master agreement may be severable, and separately assumed or rejected from, the master agreement. *See, e.g., In re Convenience USA, Inc.*, 2002 WL 230772; *In re FFP Operating Partners, LP*, Case No. 03-90171-BJH-11, 2004 WL 3007079 (Bankr. N.D. Tex. Aug. 12, 2004); *In re Cafeteria Operators, LP*, 299 B.R. 384 (Bankr. N.D. Tex. 2003).

16. The Debtors also seek to have rejection of the Leases be effective retroactively, to the date this Motion was filed (*i.e.*, the Petition Date). Retroactive rejection is appropriate where the equities of a particular case dictate. *See, e.g., In re Cafeteria Operators, L.P.*, 299 B.R. 384, 394 (Bankr. N.D. Tex. 2003); *In re Amber's Stores*, 193 B.R. 819, 827 (Bankr. N.D. Tex. 1996); *see also, e.g., In re DBSI, Inc.*, 409 B.R. 720, 734 n. 4 (Bankr. D. Del. 2009) (“under appropriate circumstances, this Court may enter a lease rejection order with an effective date earlier than the date the order is entered”) (citations omitted); *In re Jamesway Corp.*, 179 B.R. 33, 37 (S.D.N.Y. 1995) (finding that the bankruptcy court could select “a retroactive date for the effective date of rejection”); *In re Signature Styles, LLC*, Case No. 11-11733 (Bankr. D. Del. June 30, 2011), Docket No. 127 (approving rejection of executory contracts as of the petition date).

17. Finally, in order to streamline their Chapter 11 cases, the Debtors request that any counterparty to any Lease rejected pursuant to this Motion be required to file any claim such party has for alleged rejection damages no later than the date that is thirty (30) days after the entry of the Court’s order approving this Motion.

**NOTICE**

18. Notice of this Motion has been provided to: (i) counsel to the Indenture Trustee for the 9.00% Senior Secured Notes due 2016; (ii) counsel to the Indenture Trustee for the Debtors' 9.00% Convertible Senior Secured Notes due 2012; (iii) counsel to the ad hoc committee of holders of 9.00% Senior Secured Notes due 2016; (iv) the office of the United States Trustee for the Northern District of Texas, (v) the holders of the thirty (30) largest unsecured claims against the Debtors on a consolidated basis, (vi) each counterparty appearing on Exhibit "A"; and (vii) certain other parties appearing on the attached Certificate of Service. The Debtors respectfully submit that no other or further notice need be provided.

WHEREFORE, the Debtors respectfully request that the Court enter an order: (i) granting the relief requested herein and (iii) granting such other and further relief as may be just and proper.
