



As you are aware, my firm represents the Post Confirmation Trust ("PCT") 1, the representative of the estates of Fleming Companies, Inc. and its subsidiaries pursuant to the Third Amended and Revised Joint Plan of Reorganization of Fleming Companies, Inc. and Its Filing Subsidiaries under Chapter 11 of the United States Bankruptcy Code. The Plan was confirmed on July 27, 2004 by order of the United States Bankruptcy Court for the District of Delaware and became effective on August 23, 2004

By this letter agreement, pursuant to Sections 2 6, 2 7, and 7 6 of the UFCW Local 789 Settlement agreement dated July 20, 2004 (the "Original Settlement Agreement"), as amended by the Letter Agreement dated November 19, 2004 (the "First Amendment" and together with the Original Settlement Agreement, the "Settlement Agreement"), UFCW Local 789 and the PCT agree to amend the following sections of the Settlement Agreement as set forth

Section 2 1(a)(11) -- \$833,131 94 is changed to \$859,787 75,2

Section 2 5(e) – the Reserve Termination Date is changed from December 2, 2004 to April 1, 2005, and

Section 5 1 – "overnight delivery by no later than the first business day after the day" in the last sentence is changed to "first class United States mail as soon as practicable after"


Pursuant to Sections 2 5 and 2 6 and 7 6 of the Settlement Agreement, the parties agree to amend Exhibits 1, 4, and 5 to the Settlement Agreement by adding the Former Employees listed on Exhibit A attached hereto as Former Employees covered by the Settlement Agreement

Further, pursuant to 7 6 of the Settlement Agreement, the parties agree to amend Exhibit 4 to the Settlement Agreement by adding the Former Employees Claims listed on Exhibit B attached hereto (the "Omitted Former Employee Claims") The parties agree that the Former Employees who filed the Omitted Former Employee Claims were previously included in the Settlement Agreement

As shown on Exhibit A attached hereto, the amount to be paid in satisfaction of the Administrative Portions and Priority Portions is increased in the aggregate amount of \$618 49 (the "Local 789 Second Increase") The Local 789 Reserve Fund established pursuant to section 2 5(a) of the Settlement Agreement has been depleted previously Pursuant to Section 2 5(g) of the Settlement Agreement, the Local 789 Second Increase shall be paid out of the Remaining 653 Reserve Fund Amount

All other provisions of the Settlement Agreement remain unchanged and in full force and effect

² This change reflects a \$9,137 23 increase to General Unsecured Portions as a result of the First Amendment and a \$17,518 55 increase to the General Unsecured Portions as a result of three Former Employees with unsecured claims being added to Exhibits 1, 4 and 5 as shown on Exhibit A attached hereto
