

This warranty shall apply only to defects which appear within one (1) year from the date of withdrawal from consigned stock or date of Manufacturer's invoice, whichever is later, (except for defects in title, which shall have no time limitation)

If any Product delivered on any purchase order placed by Distributor under this Agreement does not meet the above warranty and if Distributor in these Manufacturer in writing within thirty (30) days after discovery of the defect. Manufacturer shall thereupon correct such defect by either (at Manufacturer's option) replacing the defective Product or part thereof (fob Manufacturer's plant or other point of shipment with freight allowed to destination within the continental United States. Alaska ind Hawaii) or refunding the price thereof

Except for hibility for patent infringement or third party claims of injury which are covered by (b) and (c) below the foregoing shall constitute the sole remedy of Distributor and the sole hability of Manufacturer with regard to warranty. Manufacturer makes no other warranty statutory or otherwise and none is to be implied. IN PARTICULAR WITHOUT LIMITING THE FORE GOING NO WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IS MADE OR 15 TO BE IMPLIED.

(b) Distributor agrees to indemnify Manufacturer for and hold Manufacturer harmless from and against any damage expense or loss that Manufacturer may suffer or be subject to by reason of infringement of patent or trademark arising from compliance with Distributor's designs or specifications modifications or instructions. Except as otherwise provided in the preceding sentence Manufacturer shall defend any suit or proceeding brought against Distributor so far as based on a claim that any Product furnished under this Agreement constitutes an infringement of any patent of the United States, if notified promptly in writing and given authority information and assistance (at Manufacturer's expense) for the defense of sam and Manufacturer shall pay any damages and costs awarded therein against Distributor In case said Product is in such suit held to constitute infringement and the sale of said Product is enjoined Manufacturer shall at its own expense and at its election either procure for Distributor the right to continue selling said Product or replace same with a non-infringing Product or modify it so it becomes non-infringing or permit the return of said Product and refund the purchase price The foregoing states the entire liability of Manufacturer for patent infringement by the said Product

Manufacturer shall not be liable for any costs or dam ages incurred by Distributor as a result of any suit or proceeding brought against Distributor so far as based on any claim (i) that use of any Product, or any part thereof furnished hereunder in combination with products not supplied by Manufacturer constitutes either direct or contributory infringement of any patent or (ii) that a manufacturing or other process utilizing any Product, or part thereof furnished hereunder constitutes either direct or contributory infringement of any patent

(c) If any independent third party institutes legal actions or claims against Distributor alleging personal injury death or property damage resulting from actual defects in Products. Distributor shall notify Manufacturer immediately of any such claims and shall permit Manufacturer to defend or settle such claims and to select counsel for such defense. Manufacturer shall pay the costs of such defense and any judgment or settlement resulting therefrom except that Manufacturer shall have no liability for claims not timely turned over to it for defense or settled without its prior written consent. Distributor shall provide all reasonable assistance to Manufacturer for the defense or settlement of all such claims. If Distributor

chooses to retail so own counsel the fees and expenses of such counsel shall be at Distributor's expense

- change the terms and conditions of this Agreement (in cluding any additional terms and conditions set forth in or referenced in Attachment A) in whole or in part at any time and from time to time with respect to Products of fered prices discounts charges (including but not limit ed to minimum order charge) allowances terms of sale terms of payment shipments delivery consignments (where applicable) and/or in any other respect. Any such changes may be made by Manufacturer without notice to Distributor other than Manufacturer's regular notice to the trade announcing such change and shall become effective on the date specified in such notice.
- 12 DURATION AND TERMINATION This Agreement shall be effective for one year from the date hereof (unless sooner terminated as herein provided) The Agreement shall be automatically renewed for another year and from year to year thereafter unless, within sixty (60) days prior to the end of the initial term, or any succeeding term thereafter either party notifies the other in writing that it does not wish to renew the Agreement in which event it shall terminate at the end of the year

Distributor may terminate this Agreement for any cause or no cause at any time upon giving written notice to Manufacturer

This Agreement is personal in its character and Manu facturer reserves the right to terminate it on one (1) day s written notice in the event of the sale or other transfer of Distributor s business to persons unacceptable to Manu facturer This Agreement is not assignable by Distributor without the prior written consent of Manufacturer and any such attempted assignment shall be void. If at any time Distributor shall be or become insolvent or the normal conduct of Distributor's business or Distributor's credit shall become impaired in the opinion of Manufacturer or if Distributor shall be or become involved in any other financial difficulty which in the opinion of Manu facturer, may impair Distributor's credit or ability to properly conduct its business hereunder, then Manufacturer may without incurring any liability to Distributor refuse to accept any orders and suspend further shipments on any outstanding orders except upon credit terms acceptable to Manufacturer and may also if Manu facturer so desires terminate this Agreement on one (1) day s written notice to Distributor Without limiting the foregoing if Distributor shall fail to make any payment when due or fail to perform any of the provisions, terms or conditions hereof on its part to be performed, or if it shall falsify any document submitted to Manufacturer or falsely claim any benefit to which it might be otherwise entitled or if it shall call any meeting of creditors, or if a receiver or trustee shall be appointed for it or its assets, or if any petition or proceeding under any provision of the Bankruptcy Act be filed or instituted with respect to it then and in any such case. Any transactions between Manufacturer and Distributor after the termination of this Agreement shall not be construed as a renewal or extension thereof nor as a waiver of the termination thereof but all such transactions shall be subject to provisions identical with those of this Agreement except as the parties may otherwise mutually agree in writing

Neither Manufacturer nor Distributor shall, by reason of any termination of this Agreement be liable to the other for compensation reimbursement or damages of any kind either on account of present or prospective profits on sales or anticipated sales, or on account of expenditures investments or commitments made in connection therewith or in connection with the establishment development or maintenance of the business or goodwill of Manufacturer or Distributor or on account of any other cause or thing whatsoever provided, however that such termination shall not affect the right or liabilities of the parties with respect to Products previously sold hereunder or with respect to any indebtedness then owing by either party to the other

13 LIMITATION OF LIABILITY Manufacturer's liability to Distributor on any claim of any kind including negligence for any loss or damage arising out of connected with, or resulting from this Agreement, or from the performance or breach thereof or from the design manufacture sale delivery resale installation inspection repair operation or use of any Product covered by or furnished under this Agreement shall in no case (except as provided in Article 9 (b) and (c) which deal with patents and third party injuries exceed the price allocable to the Product of part thereof which gives rise to the claim and shall terminate four (4) years after the date of withdrawal from consigned stock or delivery to Distributor which ever is later of the Product giving rise to the claim

In no event whether as a result of breach of contract or warranty or alleged negligence or otherwise shall either party be liable to the other for special or consequential dimages including but not limited to loss of profits or revenue loss of use of the Products furnished or any associated equipment cost of capital cost of substitute equipment downtime costs or claims of suppliers or customers of either for such damage or any special or consequential damages.

- (c) This instrument contains the entire and only agreement between the parties respecting the sale to and the purchase by Distributor of the Products referred to in Article 1 hereof All prior and collateral representations promises and conditions either oral or written in connection with said matter and any representation promise or condition not incorporated herein or made a part hereof shall not be binding upon either party

This Agreement terminates any agreement(s) which may be in effect between Distributor and Manufacturer for the distribution of Products but such termination shall not affect the rights or liabilities of either party with respect to Products previously sold under any such agrees ment or with respect to any indebtedness then owing by either party to the other under such agreement. This Agreement shall not become effective or be binding on Manufacturer until signed by an Officer or authorized Manager of GE Lighting No waiver or modification of this Agreement or of any of its terms other than a modi fication as provided in Article 11 herein may be made unless such waiver or modification is in writing and signed by such Officer or Manager Such Manager has no authority to alter prices terms or conditions without approval of General Electric Company GE Lighting

This Attachment A governs consignment and is pair the Distributor Agreement for GE Lighting Products if such Agreement covers the sale of large lamps, i.e., large incandescent, fluorescent high intensity discharge and quartz lamps (collective y referred to as Large Lamps in this Attachment) Consignment (and the provisions of this Attachment) are applicable only to such Large Lamps

#### CONSIGNMENT

- (a) Manufacturer agrees to maintain on consignment in the custody of Distributor a stock of GE Large Lamps. The sizes types classes and quantity of Large Lamps and the length of time they shall remain in stock shall be determined at the sole d scretion of Manufacturer. All Large Lamps in such stock shall be and remain the property of Manufacturer until the Large Lamps are withdrawn from said stock for sale or distribution or other use, at which time they shall become the exclusive property of Distributor to dispose of in such manner and on such prices terms and conditions as Distributor shall determine.
- (b) All Large Lamps shipped to Distributor shall be stored at Distributor's regular place or places of business (specified in the Distributor Agreement) until withdrawn for sale or distribution or other use. Until Large Lamps are so withdrawn, Manufacturer shall bear all risk of loss or damage resulting from fire action of the elements, nots, war or like catastrophe, however. Distributor shall send prompt notice of any such loss directly to Manufacturer, and Distributor shall also use reasonable efforts to minimize loss in the event of such catastrophe and thereafter cooperate with Manufacturer's insurance adjustors. Distributor shall pay Manufacturer for all Large Lamps otherwise lost or missing from or damaged in the consigned stock in its custody.
- (c) With respect to such consigned stock Distributor assumes all ordinary costs of doing business such as but not limited to, the following general categories
  - (1) Expenses for storage, cartage transportation and handling
  - (2) All taxes excises and charges, which are now or may hereafter be levied imposed or charged (whether by federal state municipal or other public authority) with respect to Large Lamps except assessed personal property taxes on consigned stock or other taxes based upon ownership of such stock
- (d) Distributor shall return to Manufacturer at any time when directed by the latter, all or any part of the said con signed stock which has not been withdrawn by Distributor for sale or distribution or other use

ACCOUNTING Distributor agrees to account monthly to Manufacturer for the consigned stock and for Large Lamps withdrawn for sale or other use therefrom on forms provided by Manufacturer Distributor shall pay to Manufacturer on the 15th day of every month an amount equal to the total price to Distributor of the Large Lamps withdrawn from consigned stock during the preceding month

For purposes of such reports, the consigned value of Large Lamps in the consigned stock will be deemed to remain the same each month (until changed as provided below) and with drawals from consigned stock shall be considered to have been equal in value to the value of shipments of Large Lamps made pursuant to Distributor's orders, and such shipments whether to its places of business or direct to its customers shall be considered as replacing Large Lamps withdrawn from consigned stock. However, if the parties agree in writing to in crease consigned stock, shipments for that purpose will not be considered as replacement of Large Lamps withdrawn from consigned stock but shall be considered as an addition to the consigned stock for which Distributor shall be accountable

Manufacturer shall have access to Distributor's places of business at all times during business hours to inspect Manufacturer's consigned stock, records related to consigned stock, shipment records of consigned stock, records related to payments or accounts due for Large Lamps and records related to security given Manufacturer therefor

Distributor must submit a complete itemized inventory of all Large Lamps in consigned stock at the close of each calen dar quarter or monthly if it elects, or at such other time as may be agreed in writing. The withdrawals from consigned stock shall be measured by the difference between the value of the previous consigned stock plus shipments made since the previous inventory pursuant to Distributor's orders and the value of such inventory.

At the time each such inventory is submitted Distributor shall pay to Manufacturer for all Large Lamps lost or missing from or damaged in, the consigned stock in its custody

Whenever a complete itemized inventory is submitted, the value of the consigned stock shall be adjusted to the current value of the Large Lamps shown on the inventory. In no event shall the value of the stock except for additions or reductions agreed upon in writing be changed unless such an inventory has been submitted by Distributor.
