## ENDNOTES

<sup>1</sup> Due to the manner in which the Fleming entities transacted business, it is not clear which Debtor entity is obligated to The Western Sugar Cooperative. While the Western Sugar Cooperative does not believe it dealt directly with this Debtor entity, The Western Sugar Cooperative has not been able to confirm if Debtors believe that The Western Sugar Cooperative did contract with this entity. Accordingly, The Western Sugar Cooperative is submitting this claim in more than a single bankruptcy case in an abundance of caution. The Western Sugar Cooperative acknowledges that it is entitled only to satisfaction of its total claim. All supporting documentation for this proof of claim is attached to the proofs of claim contemporaneously being submitted in both Fleming Companies, Inc (03-10945(MFW)) and Fleming Foods of Texas, L P (03-10955(MFW))

<sup>2</sup> In addition to the amounts included herein, The Western Sugar Cooperative previously timely submitted a reclamation claim in the aggregate amount of \$506,058.90. All requested supporting documentation has been provided to Debtors. Pursuant to the Court's April 21, 2003 Order (Docket # 510), the reclamation claim is to be treated as an administrative claim and paid in full, in cash, or secured by a lien. In the event any portion or all of The Western Sugar Cooperative's reclamation claim is ultimately not allowed as a reclamation claim, it will be automatically added to the amount of this proof of claim.
