3 Reckitt Benckiser, Inc is the successor in interest to L&F Products, Reckitt & Colman, Inc and Benckiser Consumer Products, Inc (collectively, "Reckitt") As reflected in Reckitt's records, in the ordinary course of business between Reckitt and the affiliated Fleming debtor entities that are party to the within consolidated bankruptcy case (each a "Debtor Entity" and collectively, the "Debtor Entities"), Reckitt received orders for goods from, and shipped goods to, at least the following entities Head Distributing Company, Fleming Foods of Texas,

L P , Fleming Companies, Inc and Core-Mark International, Inc Upon information and belief, Reckitt may have received orders from and/or shipped goods to, or for the benefit of, other Debtor Entities

4 Accordingly, each Debtor Entity has been unjustly enriched to the extent it used or received the benefit of the use of goods provided to other Debtor Entities, including, without limitation the specific Debtor entities listed above Additionally, principles of agency, piercing the corporate veil and the like may apply to the Debtor Entities in connection with the amounts due and owing to Reckitt Accordingly, ABCO Realty Corp (the “Debtor”) may be liable to Reckitt for up to the full amount of the monies owed in connection with the goods provided to the Debtor Entities by Reckitt, and Reckitt reserves all of its rights in this regard

5 The total amount of Reckitt’s claim against the Debtor is \$2,743,780 13 as follows

Unpaid Accounts Receivable	\$1,995,535 81
Marketing	\$ 242,750 39
Improper Payments under Military Distribution Agreements	\$ 505,493 93

A detailed schedule of the amounts due and owing to Reckitt is attached hereto as Exhibit “A” The identification of Debtor Entities contained in Exhibit A reflects the information contained in Reckitt’s records, and is without prejudice as to Reckitt’s claims against all Debtor Entities The invoices and related records referenced in Exhibit A are too voluminous to attach hereto Copies of such documents may be obtained from counsel at the address set forth above

6 The asserted claim assumes this Debtor has liability for all matters set forth herein Should certain matters be found to be inapplicable to this Debtor, the amount of this claim will be reduced It is not Reckitt’s intention to interpose duplicative claims, but to

preserve its rights and remedies against all responsible Debtor Entities for the claims set forth herein

7 On April 1, 2003, Reckitt demanded reclamation pursuant to Section 2-702 of the Uniform Commercial Code of certain goods in the amount of \$974,671.69. A true copy of the reclamation demand is attached hereto as Exhibit "B". This reclamation demand understated the amount of Reckitt's reclamation demand, which is 1,144,195.00. The subject goods were sold in the ordinary course of business and, upon information and belief, the Debtor Entities were insolvent when they received the goods.

8 On April 1, 2003, the Debtor Entities filed for protection under Chapter 11 of the Bankruptcy Code.

9 On April 29, 2003, the Bankruptcy Court entered an Order Establishing a Procedure for Treatment of Reclamation Claims which permits the Debtor Entities to refuse all reclamation demands, establishes a procedure for the review of reclamation demands and provides, inter alia, that valid reclamation claims will be treated in accordance with 11 U.S.C. § 546(c).

10 Accordingly, \$1,144,195.00 of Reckitt's unsecured claim may be entitled to administrative priority pursuant to 11 U.S.C. § 503(b).

11 Reckitt's claim for \$505,493.93 arises out of post-petition payments made by Reckitt to the Debtor Entities in connection with certain transactions under Military Distribution Agreements. The Debtor entities were, and are, not entitled to these payments by reason of their failure to pay Reckitt for the goods involved in these transactions. These payments may entitle Reckitt to payment of an administrative claim pursuant to 11 U.S.C. § 503(b), and Reckitt reserves all of its rights in this regard.

12 No note or other negotiable instrument has been received for the above claims

13 All payments made in connection with the above obligations have been deducted from the amount claimed The Debtor Entities will be provided with credit for any payment received in the future, from any source, on account of the above obligations

14 No judgment has been rendered on these obligations

15 Reckitt hereby reserves its right to amend its Proof of Claim and/or this Attachment for purposes of amending amounts due or re-classifying the character of the claims (i e oversecured, undersecured, priority, etc)


