


**ATTACHMENT TO PROOF OF CLAIM OF ACE AMERICAN
INSURANCE COMPANY, ET AL. IN IN RE FLEMING COMPANIES,
INC., ET AL., CASE NO. 03-10945 (MFW) (JOINTLY ADMINISTERED)**

ACE American Insurance Company (f/k/a CIGNA Insurance Co), ACE Insurance Company of Texas (f/k/a CIGNA Insurance Co of Texas), Insurance Company of North America, Pacific Employers Insurance Company, Indemnity Insurance Company of North America, Illinois Union Insurance Company, Bankers Standard Insurance Co and Atlantic Employers Insurance Co (and possibly other ACE USA-related companies) (collectively, the "ACE USA Companies") issued certain insurance policies for various policy periods including, without limitation, those insurance policies listed on Exhibit A attached hereto (collectively, the "Policies") in connection with various insurance programs provided to Fleming Companies, Inc and its various affiliated debtors (and other possible named insureds) (collectively, "Debtors") The ACE USA Companies are also parties to certain other agreements with various Debtors relating to such insurance coverage provided in connection with such insurance programs (collectively, the "Agreements") The documents supporting this proof of claim are voluminous and contain confidential and privileged materials, however, copies of the non-confidential portions of the Policies and/or the Agreements are available upon request

The amount of the ACE USA Companies' claims are presently only partially liquidated (liquidated claims include, without limitation, \$51,868 79 in unpaid premiums under certain Policies issued to Core-Mark, and \$1,228,566 80 due under various open invoices to various Debtors) and is subject to further and future adjustment The ACE USA Companies' claims may include, without limitation, additional premium payments, deductibles, self-insured retentions and other expenses that may become due under the Policies and/or the Agreements The ACE USA Companies may also hold claims that are presently contingent and unliquidated for any and all rights to payment, rights to receive performance, actions, defenses, setoffs and/or recoupments arising from, related to, or in connection with any and all of Debtors' (and any other possible named insureds') duties and obligations under the terms of the Policies and/or the Agreements

Some of the Policies may be loss sensitive, in that premium payments reflect Debtors' actual loss experience including, without limitation, losses that have been incurred but not reported Some of the Policies may be auditable, meaning that premium payments are subject to periodic adjustments based on changes to underwriting factors Actual premium payments due are subsequently determined by actual losses and expenses and reimbursement of deductible amounts, subject to the terms of the Policies and/or the Agreements As such, the ACE USA Companies will likely, and reserve the right to, from time to time, amend the amount of this proof of claim based on audits and/or adjustments related to Debtors' claims and actual loss experience

The ACE USA Companies hold certain letters of credit (and, possibly, certain cash proceeds of such letters of credit and/or other collateral) ("Collateral") to secure Debtors' obligations under certain Policies and/or the Agreements The amount of Collateral is approximately \$31,417,692, and may be subject to further adjustments.

A portion of the ACE USA Companies' claims may be entitled to (i) administrative expense priority under sections 503(b) and 507(a)(1) of the Bankruptcy Code for workers' compensation and other insurance coverage provided on or after the commencement date of Debtors' bankruptcy cases and/or (ii) priority under section 507(a)(4) of the Bankruptcy Code for employee benefit coverage (under workers' compensation insurance) for the period of 180 days prior to the commencement of Debtors' bankruptcy cases

The ACE USA Companies reserve the right to amend, update, supplement, modify, increase or otherwise further liquidate this proof of claim from time to time for any reason necessary to accurately reflect the amount or nature of the claims being asserted and the list of Policies attached as Exhibit A. To the extent that the ACE USA Companies may have rights against any other related debtors of which they are not presently aware, or such related debtors claim rights to, or interests in, the Policies, the Agreements and/or the Collateral, this proof of claim should be deemed filed in each such separate case. The ACE USA Companies further reserve (i) the right to assert separate requests for payment of administrative expense or other priority claims under section 503(a) of the Bankruptcy Code against one or more Debtors if, as and when the Policies and/or the Agreements are determined to be executory contracts within the meaning of section 365 of the Bankruptcy Code, (ii) the right to request adequate protection of their interests in the Policies, the Agreements, the Collateral and/or otherwise, (iii) the right to assert any claims which may arise in any subsequent litigation regarding any aspect of the Policies, the Agreements, the Collateral or otherwise, and/or (iv) the right to assert any such claims which are otherwise warranted under the circumstances.

This proof of claim shall not be deemed to be a waiver of, and is without prejudice to, (i) the right of the ACE USA Companies to have final orders in non-core matters entered only after *de novo* review by a United States District Judge, (ii) the right of the ACE USA Companies to arbitrate any dispute in accordance with the terms of the Policies and/or the Agreements or, alternatively, to trial by jury in any proceeding so triable in these cases or any case, controversy, or proceeding related to these cases, (iii) the right of the ACE USA Companies to request the United States District Court to withdraw the reference or to abstain in any matter subject to mandatory or discretionary withdrawal or abstention, and/or (iv) any and all of the ACE USA Companies' rights, claims and/or defenses of any nature whatsoever under the Policies, the Agreements, the Bankruptcy Code and/or any otherwise applicable law.
