A copy of this reclamation demand letter is attached hereto as Exhibit A.

Pursuant to 11 U S C \S 546(c)(2), the court may deny reclamation to a seller with a right of reclamation that has made a demand only if the court (a) grants the claim of such seller priority as a claim of a kind specified in section 503(b) of the Bankruptcy Code (i.e. an administrative expense priority claim) or (b) secures such a claim with a lien. To date, the reclamation claim of Lykes in the amount of \$150,503 39 has neither been secured by a lien nor granted administrative expense priority status by the Court. To preserve its right to allowance of its reclamation claims as authorized under 11 U S C \S 546(c)(2) and applicable non-bankruptcy law, Lykes has indicated that the portion of its claim related to its reclamation \S 150,503 39 is a secured claim and/or a priority claim
