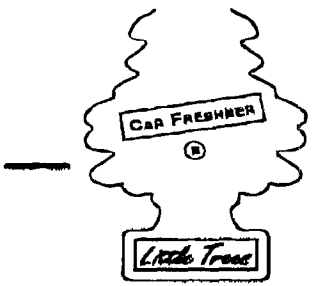


The Proof of Claim relates to approximately six (6) invoices dated from February 3, 2003 to March 13, 2003, inclusive
