NOTICE OF DEADLINE FOR FILING CERTAIN ADMINISTRATIVE CLAIMS

NOTICE IS HEREBY GIVEN THAT

1 The Court has fixed **January 15, 2004, at 4 00 p m Eastern Standard Time** as the deadline (the "Administrative Claims Bar Date") by which all **Administrative Claims** (as defined below) against the Debtors **that arose on or after April 1, 2003, through and including October 31, 2003**, must be filed **IF YOUR CLAIM AROSE PRIOR TO APRIL 1, 2003, THIS NOTICE DOES NOT AFFECT YOU, AND YOU SHOULD NOT FILE A PROOF OF ADMINISTRATIVE CLAIM**

2 An Administrative Claim is any Claim (as hereinafter defined), that **arose on or after April 1, 2003 through and including October 31, 2003**, which entitles the claimant to priority of payment pursuant to sections 503 and 507(a)(1) of the Bankruptcy Code, except that holders of the following types of Administrative Claims need not file such Claims by the Administrative Claims Bar Date (i) Administrative Claims of professionals retained pursuant to sections 327 and 328 of the Bankruptcy Code, (ii) expenses of members of the Official Committee of Unsecured Creditors, (iii) all fees payable and unpaid under 28 U S C § 1930, (iv) any fees or charges assessed against the estates of the Debtors under 28 U S C §123, (v) any intercompany claims between the Debtors and their affiliates, (vi) Administrative Claims arising in the ordinary course of business relating to inventory, services or supplies provided by trade vendors or service providers which are paid or payable by the Debtors in the ordinary course of business, (vii) claims for reclamation asserted pursuant to section 546(c) of the Bankruptcy Code, (viii) Administrative Claims relating to executory contracts or unexpired leases that have neither been rejected nor assumed by the Debtors, as well as Administrative Claims relating to, or arising under, executory contracts or unexpired leases, regardless of whether such executory contracts or unexpired leases have been assumed or rejected, that are unknown to the claim holder, (ix) Administrative Claims that have previously been filed or for which any request for payment pursuant to section 503(a) of the Bankruptcy Code or adversary proceeding is pending, and (x) any claims of the Pre-Petition Agents and Pre-Petition Lenders as well as those of the Post-Petition Agents and Post-Petition Lenders arising under or in connection with the Pre-Petition Loan Documents, Post-Petition Loan Documents, and/or the Final DIP Order

3 **Section 503** of the Bankruptcy Code defines administrative expense claims, in part as "**all necessary costs and expenses of preserving the debtor's estate including wages, salaries, and commissions** (and any taxes withheld from such wages, salaries or commissions)" If you (a) supplied goods or services to any of the Debtors, (b) during the period from April 1, 2003 through and including October 31, 2003, and (c) have not been paid for those goods or services, then you may have an administrative claim **If you provided goods or services prior to April 1, 2003, then you do not have an administrative claim for those goods or services** Please consult your legal adviser if you have any uncertainty whether your proposed claim may constitute an Administrative Claim The preceding explanation is solely intended to provide guidance, not to serve as legal advice

4 Any person who asserts an Administrative Claim and wishes to have such Administrative Claim allowed by the Court and paid by the Debtors must file a request for such Administrative Claim so that it is received by Bankruptcy Management
