3. Pertinent Facts and Circumstances in Connection with the Employment of Gilbert L. Hamberg, Esquire



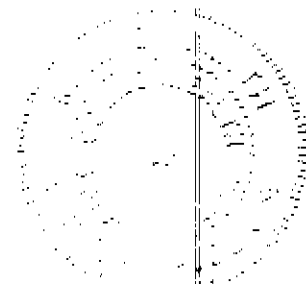


