Dear Anne:

We represent Fleming, Inc. and its related debtor entities ("Fleming" or "the Debtors") in connection with its bankruptcy proceedings including its reclamation process. Pursuant to the Bankruptcy Court's Order, Under 11 U.S.C. Sections 105(a), 503(b), 546(c)(2) and 546 (g), (A) Establishing Procedure for Treatment of Reclamation Claims and (B) Prohibiting Third Parties From Interfering With Delivery Of Debtors' Goods ("the Order") signed on April 22, 2003, we have started to analyze letters received by Fleming that may represent reclamation demands.

In accordance with the Order, each Claimant upon written request from the Debtors, shall provide such additional documentation that may be in Claimant's possession as is reasonably needed to assist Debtors in the evaluation of the Claimant's reclamation claim. This letter serves as a request for additional information to evaluate your reclamation claim. Please provide Fleming with a spreadsheet that contains the details of your reclamation claim including the following four information fields:

- Purchase Order #
- Invoice Date
- Invoice Number
- Invoice Amount

Certain vendors may have provided this information in hard copy form along with the reclamation claim. However, in order to expedite the process, we are requesting to receive this data from all reclamation claimants in an electronic format. The preferred deliverable would be in Microsoft Excel. If that is not possible, please use another electronic method.
