REJECTION DAMAGES CLAIM

Schneider Foods, Inc., by their attorneys Werb & Sullivan, for their rejection damages claim as follows:

1. Schneider Foods, Inc. operated a Sentry brand supermarket in Port Washington, Wisconsin. (the “Store”).
2. Schneider Foods, Inc. operated the Store under a sublease with the Debtors, identified by the Debtors as 7079, WI-085.a (the “Lease”).
3. The Lease was rejected pursuant to an Order of the Bankruptcy Court dated November 8, 2003.
4. As a result of such rejection, Schneider Foods, Inc. was damaged in the amount of \$150,000.00.
5. The supporting documents for this claim are already in the hands of the Debtors, but are available upon request.
