Dear Honorable Judge,


The Stace Williams Law Firm is submitting this Motion as a response (objection) to the "Notice of Hearing on Approval of Disclosure Statement In Support of Debtors Joint Plan of Reorganization of Fleming Companies, Inc. and its Filing Subsidiaries Under Chapter 11 of THE UNITED STATES BANKRUPTCY CODE."

Our firm represents Maria Louisa Reyes in a personal injury claim against Fleming Companies, Inc. dba Rainbow Foods. Our firm sent a letter of representation and a settlement demand of \$65,000 to the company (through ESIS; Jackie Watford, National Claims Representative). Ms. Watford did confirm (letter dated August 27, 2003) that Ms. Ramirez's information was forwarded to the Court in April. 
