Upon the motion of unsecured creditor Estate of Jay Clauss, under Bankruptcy Code section 362(a) for relief from the automatic stay as hereinafter set forth, and for cause shown, it is

ORDERED that the automatic stay is vacated to permit the movant to institute or resume and prosecute to conclusion one or more actions in the court(s) of appropriate jurisdiction to pursue the movant's rights in the following:

Movant is permitted to commence litigation against the debtor with respect to the wrongful death of Jay Clauss and prosecute the action, limiting recovery to the insurance proceeds. The 14-day stay waiver is hereby lifted. If there is no available insurance for recovery, movant will make the proper application to the Court.

It is further ORDERED that the movant may join the debtor and any trustee appointed in this case as defendants in its action(s) irrespective of any conversion to any other chapter of the Bankruptcy Code.

The movant shall serve this Order on the debtor, any trustee and any other party who entered an appearance on the motion.
