



1 by the wineries.

2 10. Upon release of the wine by the winery, the general  
3 expectation is that the value of the wine will appreciate.

4 11. On six occasions, beginning in February, 2011 through  
5 July 7, 2011, for financial consideration, plaintiff and  
6 defendants agreed, in writing, that defendants would deliver to  
7 plaintiff future specified premium Bordeaux wines.

8 12. The aggregate amount paid by plaintiff to defendants  
9 for the wine futures was \$60,000.00.

10 13. Attached hereto collectively as Exhibit 1, and  
11 incorporated herein by this reference, are copies of the orders  
12 for wine futures purchased from defendants by plaintiff.

13 14. At the time that plaintiff purchased the wine futures  
14 from defendants, defendants assured plaintiff that the wines  
15 would be delivered to plaintiff in 2013 or 2014, depending upon  
16 the date that the individual winery chose to release the wine.

17 15. Plaintiff is informed and believes, and thereon alleges  
18 that the wine futures purchased by plaintiff were released by the  
19 wineries in or about 2014.

20 16. Beginning in or about January, 2015, plaintiff inquired  
21 of defendants about the delivery dates of the wines ordered by  
22 plaintiff.

23 17. At all material times, defendants either have ignored,  
24 and failed to respond to, plaintiff's inquiries; or have  
25 proffered one reason or another for failing to deliver the wines  
26 purchased by plaintiff.

27 18. On August 12, 2015, plaintiff demanded that defendants  
28 provide plaintiff with a firm date that defendant would deliver

1 the wines to plaintiff.

2 19. Defendants have breached the agreement they made with  
3 plaintiff by refusing and/or failing to deliver to plaintiff the  
4 wine that was purchased by plaintiff, or to provide plaintiff  
5 with a firm date for the delivery of the wines.

6 20. By reason of the foregoing, plaintiff has been damaged  
7 in an amount according to proof at trial, but not less than the  
8 sum of \$60,000.00, together with interest thereon in an amount  
9 according to proof.

10 21. Plaintiff has performed all obligations to defendants  
11 except those obligations plaintiff was prevented or excused from  
12 performing.

13 WHEREFORE, plaintiff prays for Judgment as set forth below.

14 SECOND CAUSE OF ACTION  
15 (Common Count- Money had and received)

16 22. Plaintiff realleges, and incorporates herein by this  
17 reference, the allegations of paragraphs 1 through 20, inclusive,  
18 of this Complaint.

19 23. Commencing in 2014, in Berkeley, California, defendants  
20 became indebted to plaintiff in the sum of \$60,000.00 for money  
21 had and received by defendants for the use and benefit of  
22 plaintiff.

23 24. Neither the whole nor any part of the foregoing sum has  
24 been paid, although demand therefor has been made, and there now  
25 is due, owing, and unpaid the sum of \$60,000.00, with interest  
26 thereon in an amount according to proof.
