
## Explanation of Proof of Claim

Over the past seven years, I have purchased wines from the Debtor which it has failed to deliver. I paid a total of \$13,354.26 for these wines.

On July 20, 2015, I received an email from the Debtor which contained a list of all of my open orders as of that time. An "Open Order" is an order for wine which I paid for upon ordering and which has never been delivered. I enclose a copy of the email and list which totals \$11,300.34. In addition, subsequent to preparation of that list, I additionally purchased 31 bottles of wine for which I paid \$2053.92. I enclose a copy of the sales orders. These wines, also, have never been delivered.

Thus, I paid a total of \$13,354.26 for wines that have never been delivered.

If I were to purchase these same wines today, they would cost an additional \$4006. My claim therefore totals \$17,360.

These appear to be orders where the original purchase agreement have fallen through with our suppliers. In this situation, we can either continue to track down these wines which will require more time, or we can offer a substitute wine which we can switch for your old orders.
