

Dear Tony:

This letter shall confirm our conversation on November 17, 2015 at which time we confirmed our understanding regarding the resolution of my outstanding account with Premier Cru.

As you know, in 2009, I purchased one case of 2008 Lafite and one case of 2008 Pichon Lalande. I spoke with James on multiple occasions throughout the years, and each time he assured me that the wines would be delivered within the next month or two. Recently, the 2008 Pichon Lalande arrived and I had it picked up at Premier Cru by son-in-law who lives in San Francisco.

Based upon the fact that the 2008 Lafite is not presently in stock and Premier Cru could not tell me when I might receive it, we agreed to the following:

- 1. Premier Cru will reimburse me the cost of the 2008 LaFite, including the tax in a check in the amount of \$2,765.50. Per our conservation, you requested the check on October 19, 2015. It is my understanding that the check will be sent to me and arrive prior to November 20, 2015;
- 2. Premier Cru has issued me a credit memo in the amount of \$6,184.43 to be used at the store.

Hello Joel,

As per our conversation today, I have scheduled your in stock case to be pulled from the warehouse and staged for pickup at the store by your son in law. That case will be on our customer pickup shelves by tomorrow Thursday 6-26. Anytime tomorrow or thereafter that he comes by during store hours, this case will be waiting for him. Store hours are 10-6 M-F, 10-5 Saturday, closed Sunday. The address of the store in listed in my footer below.

Next, you still have this wine remaining on your backorder, that has not gotten here yet:

Yes these 2008 high end Bordeaux have taken forever to get here, and we do thank you for your patience. As we discussed, we are prepared to offer you a refund to a store Credit if you do not want to wait any longer for these. Recognizing that the wine has accrued in value in the marketplace since we sold it to you (although even back then we sold it well below the going price for the wine), we are prepared to offer you a 100% upgrade over the amount you paid for the wine, if refunded to a store Credit.

Store Credit never expires, and would automatically be used against your future orders, once issued. If you chose bottles listed as IN STOCK, those could of course ship out (or be picked up) whenever you chose to schedule it. You will find all our inventory listed on the website at <a href="https://www.premiercru.net">www.premiercru.net</a>, and you may wish to peruse it. Each wine on the website is listed as either IN STOCK or PRE-ARRIVAL. Some pre-arrivals may be coming in a few weeks, some in a few years, depending on the wine. If you are interested in a specific wine listed as pre-arrival, I may be able to enlighten you on its likely arrival timeframe. Because store Credit never expires, you do not have to use it immediately. We are constantly purchasing and offering new wines, so you could pick and choose over time if you wish.

Of course you are also welcome to keep the Lafite on your backorder. However the Credit may be a way to leverage your previous purchase into more immediate gratification, and at a handsome upgrade over what you paid. Let me know if you want to move forward with that Credit and I will set things in motion here. Let me know if you do see something that you want and I can hold that for you pending issuance of the Credit, so it does not disappear or increase in price.
