I spoke with you on Dec 9 and you agreed to refund the amount I'd previously paid for undelivered wine from order nos. SO-0000429313 and SO-0000393180. I see that my order history now shows these orders as closed and the quantity ordered of the undelivered bottles as 0. Does this mean that a check has been issued? If not, when can I expect it? Thanks for your help, <u>Rick Cecala</u> <u>Phoenix AZ</u> 602 852-0104 1. On September 29, 2012, I ordered ten bottles of wine from Premier Cru, for which my USAA Visa card was charged \$630.90 (Exhibit A). Eight bottles were eventually delivered but two bottles, Item 45000, for which I had paid a total of \$159.98, were not. I telephoned about their status and was told that shipment from Europe had been delayed.

2. On November 27, 2013, I ordered three bottles of wine from Premier Cru, for which my USAA Visa card was charged \$289.97 (Exhibit B).

3. As of December 9, 2015, these five bottles had not been delivered and were shown as outstanding on my Premier Cru order history (Exhibit C). On that date, I requested via email and telephone a refund for the five undelivered bottles and was told that my refund request would be submitted for processing (Exhibit D). I did not hear back from Premier Cru but noticed on December 22, 2015, that my online order history had been changed to show these orders as closed and the number of undelivered bottles as 0 (Exhibits E, F).

4. On December 29, 2015, I sent an email requesting a status update and on December 30, 2015, a Premier Cru employee advised me that "a credit memo was issued on 12/22 for your refund, meaning it has been processed by the accounting department and sent to the owner to be written and mailed. Unfortunately, I don't have the ability to get information on when exactly that would be mailed at this time." (Exhibit G.)

5. I did not receive a refund. Sometime after January 8, 2016, I learned that on that date Premier Cru had filed a Chapter 7 Bankruptcy petition in the Northern District of California.

I've bought wine from you for many, many years and never had a problem. However, I have two open orders currently, one of which is over 2 years old and the other over three years old. I haven't been able to reach anyone at PC by phone. At this point, I would like to be issued a refund for the undelivered wine (\$449.95 total). Can you please do so?




