**PROOF OF CLAIM OF CREDITOR  
ALLAN SHENOI, AND DECLARATION  
& EXHIBITS OF CREDITOR ALLAN  
SHENOI IN SUPPORT OF CLAIM**

I, ALLAN A SHENOI, declare on personal knowledge as follows:

1. I make a Claim for a total of \$19,165.68.
2. I paid **\$3,228.55** via credit card (American Express) to the Debtor for merchandize identified on the pages attached as Exhibit A, none of which was delivered to me.
3. I have recently made a claim to American Express to reverse these charges on my credit card. As of the date of this Claim being filed and my declaration, American Express has not done so to my knowledge. If it does, I will revise my Proof of Claim to delete the sum that American Express reverses on my credit card.

4. I claim 10% interest on the principal sum of \$3,228.55. This interest (through December 2016) is at least **\$1937.13**. Through December 2015 I calculate it as \$1614.31.

5. In addition, I claim **\$4,000** in general damages for what I contend is the Defendant's tortious act of conversion, for eight hours of my time (excluding time spent on litigation related items) at \$500 per hour. (I have been approved in Court for an hourly rate of \$700.) "Conversion is the wrongful exercise of dominion over the property of another. The elements of a conversion are the plaintiff's ownership or right to possession of the property at the time of the conversion; the defendant's conversion by a wrongful act or disposition of property rights; and damages." (*Farmers Ins. Exchange v. Zerin* (1997) 53 Cal.App.4th 445, 451-452 (*Zerin*)). "Indeed, an action for conversion rests simply upon the interference with the plaintiff's dominion over his property. The action is a species of strict liability in which the defendant's good faith, due care, ignorance or mistake are irrelevant and may not be set up as a defense. (*Edwards v. Jenkins* (1932) 214 Cal. 713, 721; *City of Los Angeles v. Superior Court* (1978) 85 Cal.App.3d 143, 149; *Henderson v. Security Nat. Bank* (1977) 72 Cal.App.3d 764, 770-771.)" *Krusi v. Bear, Stearns & Co.*, 144 Cal. App. 3d 664, 672 (Ct. App. 1983).

Cal. Civil Code § 3336 is titled "Personal property; conversion; presumption" and states:

The detriment caused by the wrongful conversion of personal property is presumed to be:

First--The value of the property at the time of the conversion, with the interest from that time, or, an amount sufficient to indemnify the party injured for the loss which is the natural, reasonable and proximate result of the wrongful act complained of and which a proper degree of prudence on his part would not have averted; and

Second--A fair compensation for the time and money properly expended in pursuit of the property.

"To entitle a party to such compensation the [evidence] should tend to show that money was properly paid out and time properly lost in pursuit of the property, and how much." (*Sherman v. Finch* (1886) 71 Cal. 68, 72.)" *Haines v. Parra*, 193 Cal. App. 3d 1553, 1559 (Ct. App. 1987).

6. I claim **\$10,000** in punitive damages. The basis for this claim is that causes of action for conversion also support the award of exemplary damages. (*Ferraro v. Pacific Fin. Corp.* (1970) 8 Cal.App.3d 339, 351; *Haun v. Hyman* (1963) 223 Cal.App.2d 615, 619-620.) To support punitive damages, the complaint asserting one of those causes of action must allege ultimate facts of the defendant's oppression, fraud, or malice. (Civ.Code, § 3294.) 'Malice is properly pleaded by alleging the wrongful motive, intent or purpose.' (3 Witkin, Cal.Procedure (2d ed.) Pleading, § 766.) 'A general

allegation of (that) intent is sufficient . . .’ (*Unruh v. Truck Insurance Exchange* (1972) 7 Cal.3d 616, 632.” *Cyrus v. Haveson*, 65 Cal. App. 3d 306, 316-17 (Ct. App. 1976).

I seek \$10,000 in punitive damages for Defendant’s and its managing agents’ deliberate scheme to defraud customers like myself, knowing, they would be unable to fulfill these orders, and, as managing agents, permitting and encouraging false promises to be misrepresented to me, as to what would be delivered to me, as the customer, once I placed an order. I relied on these false promises when I paid \$3,228.55 on my credit card.

7. I intend to file the identical Claim in the bankruptcy of the joint-tortfeasor John Eugene Fox, Bankruptcy No 16-40340, because, in my view, they are both jointly liable for all of these damages.

I declare under penalty of perjury under the laws of the United States and the State of California that the foregoing is true and correct, and that I can and will testify thereto if called as a witness in this action.


