



I may see interest on your next statement even if you pay the new balance in full and on time and make no new charges. This is called "trailing arest." Trailing interest is the interest charged when, for example, you didn't pay your previous balance in full. When that happens we charge arest from the first day of the billing period until we receive your payment in full. You can avoid paying interest on purchases by paying your ance in full and on time each month. Please see the "When we charge interest" sub-section in your Cardmember Agreement for details.
