

Dear Court Clerk,

I have attached documentation supporting my claim for \$3,316.72, which includes nine (9) bottles of Bordeaux in the Debtor's warehouse. This Bordeaux wine is referenced in my "Order History" (downloaded from Premier Cru's website on 12/19/15) purchased on 1/7/14 and 2/5/14 (see invoices). Note that this wine is indicated as "available" for shipping.

In addition to my attached "Order History" and invoices for wine purchased and not delivered, I have supporting recordings of most of my telephone conversations with Premier Cru's staff which affirm the hard copy documentation. (I worked law enforcement in New York for almost 18 years.) I also have credit card statements for each purchase, and I was not able to recoup any money for these purchases from my credit card companies. In December, 2015, I requested delivery of the available Bordeaux (as per their instruction), but I received no response from Premier Cru.
