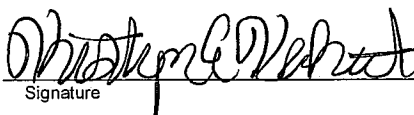

16 I, Sara Kauffman, declare as follows:

17 1. I have been employed by Antony Beck since July 2012. I have personal
18 knowledge of each fact stated in this declaration. I submit this declaration in support of
19 Mr. Beck's Proof of Claim.

20 2. One of my duties as an employee of Mr. Beck is to place orders for wine, track
21 those orders, and ensure that the wines are properly delivered.

22 3. In order to support Mr. Beck's Proof of Claim, I coordinated and participated in a
23 search of his records to compile Sales Order confirmations of Mr. Beck's wine purchases that
24 were never delivered by Premier Cru, which I have learned is another name for Fox Ortega
25 Enterprises, Inc.

4. My team and I were able to locate Sales Order confirmations for most of the outstanding wine purchases. In some instances, where the Sales Order was missing, we were able to locate email communications with Premier Cru confirming the order.

5. Despite our diligent search, my team was unable to locate records for wine purchases made on three dates: September 26, 2012, April 30, 2013, and June 18, 2014. The wine purchases from those dates, however, were included in a spreadsheet that we provided to John Fox, Premier Cru's principle, numerous times during Mr. Beck's civil litigation against Premier Cru, which was entitled: *Beck v. Fox Ortega Enterprises, et al.*, Case No.: RG15794581, Alameda County Superior Court. Mr. Fox never disputed the wine purchases contained in the spreadsheet.

6. A true and correct copy of the spreadsheets and supporting documents gathered by my team and me to support Mr. Beck's claim is attached as **Exhibit A**.
