

On 1/27/16 @ $^{\sim}1340$ H, I spoke with an associate of yours (Haley) about the dispute. I was informed to submit and paperwork that would be relevant to the claim. She informed me that since the arrival date was November/December of 2015, these would all be within the appropriate timeframe for dispute.

The charges/purchases in question are (\$599.99 on 6/7/13, \$464.97 on 5/1/13, \$109.99 on 4/20/13, and \$199.99 on 4/13/13 for a total of \$1374.94); all these purchases are all considered "pre-arrival or futures" — with an anticipated arrival date of > 2years as indicated on the merchant's "terms & conditions". These orders remained "open" & unfulfilled at the initiation of my claim; to date they all still remain unfulfilled. Included below are the requested documents:
