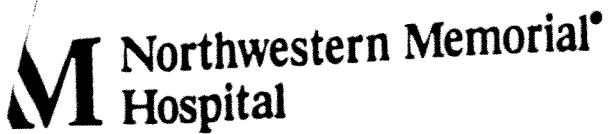

Attention Billing Disputes:

I am writing in reference to a rejected claim/case #73093904 submitted in January 2016. Following rejection of the claims via e-letter on 1/19/16, I contacted Bank of America Billing Disputes to inquire about the specifics of rejection. On 1/27/16 @ ~1340H, I spoke with an associate of yours (Haley) about the dispute. I was informed to submit and paperwork that would be relevant to the claim. She informed me that since the arrival date was November/December of 2015, these would all be within the appropriate timeframe for dispute.

The charges/purchases in question are (\$599.99 on 6/7/13, \$464.97 on 5/1/13, \$109.99 on 4/20/13, and \$199.99 on 4/13/13 for a total of \$1374.94); all these purchases are all considered "pre-arrival or futures" – with an anticipated arrival date of > 2years as indicated on the merchant's "terms & conditions". These orders remained "open" & unfulfilled at the initiation of my claim; to date they all still remain unfulfilled. Included below are the requested documents:

Document #1 – my Dispute Letter

Document #2 – "terms & conditions of Pre-arrival orders" of Premier Cru

Document #3 – all "open" and "unfulfilled" orders/purchases

Documents #4/5 – unfulfilled/open order for \$599.99 on 6/7/13 for one 750ml bottle of 2011 Rousseau Gevrey Chambertin-Clos de Beze. Half of this original order was fulfilled on 11/13/15 (one 750ml bottle of 2011 Rousseau Chambertin). Both bottles marked as "pre-arrival" when ordered.

Documents #6/7 – unfulfilled/open order for \$464.97 on 5/1/13 for 3 bottles Clos des Lambrays. All bottles marked as "pre-arrival" when ordered.

Documents #8/9 – unfulfilled/open order for \$109.99 on 4/20/13 for 1 bottle of 2011 Jadot Chambolle Musigny Fuees (one magnum bottle, 1500ml). This bottle marked as "pre-arrival" when ordered.

Documents #10/11 – unfulfilled/open order for \$199.99 on 4/13/13 for 1 bottle of 2011 Jadot Gevrey Chambertin Clos St Jacques (one magnum bottle, 1500ml). This bottle marked as "pre-arrival" when ordered.

Additionally, I have made other purchases during the same time frame & those orders were fulfilled/delivered on 11/13/15 – all of the above "open"/unfulfilled wines had a similar delivery time frame & were not included, thus this claim. Below are a summary of all purchases (document #16) I've made with the retailer Premier Cru (displaying open vs closed orders).

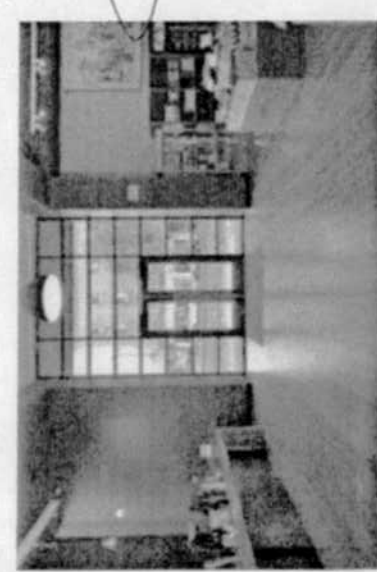

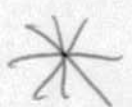


PRE-ARRIVAL VS. IN-STOCK
