interests of the Estate and creditors until the assets are disposed of, and for good cause appearing, IT IS HEREBY ORDERED that:

- 1. The Trustee is authorized to pay all utilities, including PG&E to maintain the proper temperature in the premises to protect the wine inventory and to operate the necessary computer systems, estimated not to exceed \$4,500 a month.
- 2. The Trustee is also authorized to pay Bay Alarm up to \$500 a month to maintain the current alarm system, and Bay Alarm is hereby directed to change any and all passwords at the Trustee's direction, if not changed as of the date of this Order.
- 3. The Trustee is authorized to pay for internet services, domain name services and web host fees
- 4. The Trustee is authorized to pay the sum of \$16,280 for Besso Limited Cargo Insurance policy attached to the Declaration of Michael Kasolas.
- 5. The Trustee is authorized to pay up to the sum of \$3,497.50 for property and premises liability insurance.
- 6. The Trustee may use \$23,765 in the cash collateral of Community Bank of the Bay ("Bank") for the expenses set forth hereinabove. The Trustee will use his best business judgment to pay the claims set forth herein, up to the amount of cash collateral available.
- 7. As additional adequate protection for any diminution in the amount of the Bank's collateral solely as a result of the Trustee's use of said collateral pursuant to the terms of this Order or any subsequent Order, the Bank is hereby granted a replacement lien that is valid, nonavoidable and perfected to the same extent, priority and validity of the lien that the Bank had on this Debtor's personal property as of the date of the commencement of this case. In no event shall this Order be interpreted to provide Bank a lien on any avoidance actions arising under Bankruptcy Code Sections 544, 545, 546, 547, 548, 549, 550 or any provisions of the Bankruptcy Code ("Avoidance Actions").
