Came on to be heard the Motion to Lift Stay of Yaretzi I Herenandez, a Minor by and through her Guardian Ad Litem, Cesar Hernandez (Movant) and the Court having reviewed the pleadings on file and upon agreement of the parties as shown by the signatures of counsel affixed hereto, is of the opinion that the relief sought in the Motion should be granted. It is therefore

ORDERED ADJUDGED AND DECREED that the automatic stay of Section 362 of Title 11 of the United States Code is hereby terminated as to the personal injury suit pending between Movant and Hometown Buffet Inc. under case number 37-2019-00007654-CU-PO-CTL in the Superior Court of California for the County of San Diego. It is further

ORDERED ADJUDGED AND DECREED that Movant agrees to only look to the insurance proceeds in the settlement of the suit and that Movant waives any claims against the bankruptcy estate of Hometown Buffet, Inc. or its affiliates.
