### Notes to the Monthly Operating Report

#### **General:**

(3002); Tahoe Joe's Inc. (7129); OCB Restaurant Company, LLC (7607); OCB Purchasing, Co. (7610); Ryan's Restaurant Group, LLC (7895); Fire Mountain Restaurants, LLC (8003); Food Management Partners, Inc. (7374); FMP SA Management Group, LLC (3031); FMP-Fresh Payroll, LLC (8962); FMP-Ovation Payroll, LLC (1728); and Alamo Buffets Payroll, LLC (0998).

Buffets, LLC and its direct subsidiaries have not kept accounts payable for themselves, therefore payables of Buffets, LLC subsidiaries including Hometown Buffets, Inc, OCB Restaurant Company, LLC, OCB Purchasing, Co., Ryan's Restaurant Group, LLC and Fire Mountain Restaurants, LLC are included in Buffets, LLC.
