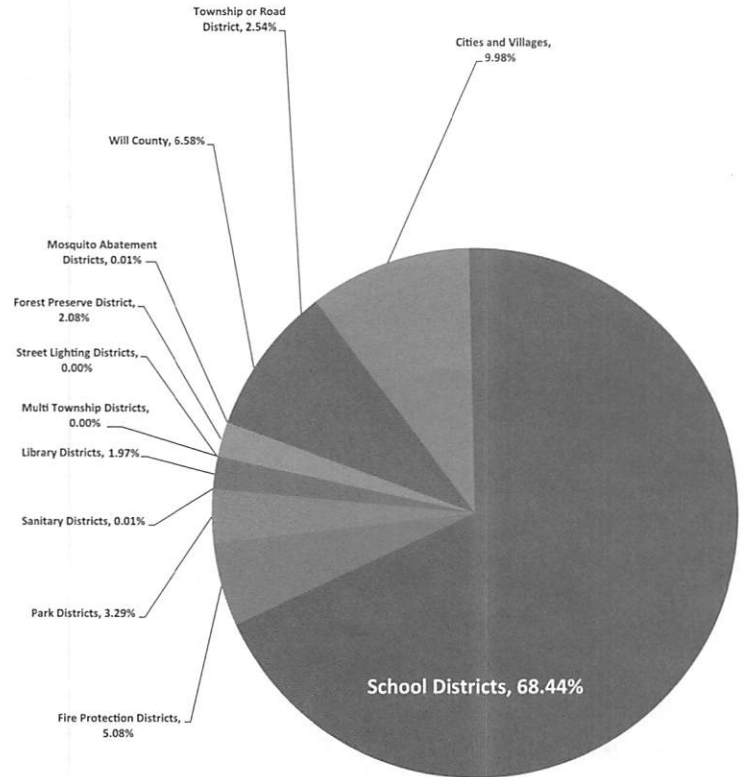
- The last day to pay your taxes online is 4:30 p.m., Nov. 20, 2015.
