**EMERGENCY MOTION FOR ENTRY OF AN ORDER
CONFIRMING GRANT OF ADMINISTRATIVE
STATUS TO OBLIGATIONS ARISING
FROM POSTPETITION DELIVERY OF GOODS**

COME NOW, CEI Roofing, Inc. and its affiliated debtors and debtors in possession (collectively, the “Debtors”), and file this Emergency Motion for Entry of an Order Confirming Grant of Administrative Status to Obligations Arising From Postpetition Delivery of Goods (the “Motion”). In support of the Motion, the Debtors would respectfully show the Court the following:

I. JURISDICTION

1. This Court has jurisdiction to consider the Motion creating this contested matter pursuant to 28 U.S.C. §§ 157 and 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b)(2)(A) and (O). Venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409. The relief requested in the Motion is authorized under Section 105(a) of the United States Bankruptcy Code (the “Bankruptcy Code”).

II. BACKGROUND

2. General Roofing Services, Inc., (“GRS”) the parent corporation, is a Florida corporation founded in 1998 and has become the nation’s leading comprehensive provider of commercial roofing solutions in the United States. GRS has a national presence through twenty-eight operating subsidiaries and thirty-six operating locations in twenty-three states. GRS’s services include: (i) new roof construction; (ii) replacement or restoration of existing roofing systems; and (iii) emergency and proactive maintenance services. GRS provides these services to commercial multi-property owners and managers in a variety of industries. The service segment of the business provides on call repairs as well as proactive repairs, proactive inspection and maintenance. The construction segment provides roofing systems for new buildings, replacement of significantly damaged roofs, and restoration of existing, mature roofs.

3. The facts and circumstances supporting this Motion are further set forth in the Affidavit of Gerard Mozian, Chief Financial Officer of GRS, in support of certain first day motions (the “Affidavit”) filed contemporaneously herewith.

III. ANALYSIS

4. In the ordinary course of the Debtors’ businesses, a number of vendors (the “Vendors”) provide the Debtors with merchandise, equipment, supplies, products and related items (collectively, the “Goods”). As of the Petition Date, certain of such Goods may be in transit to the Debtors’ facilities.

5. The Debtors maintain a decentralized purchasing process for their business operations. Thus, each of the twenty-eight Debtors operating throughout the country issues its own purchase orders for the Goods necessary to run its operations and provide services to its customers. These individual Debtors each issue large numbers of purchase orders for Goods each week. As of the Petition Date, each of the Debtors had a large number of outstanding

orders with Vendors for Goods critical to keeping its business operating. As a result of the filing of this Chapter 11 case, Vendors may be concerned the delivery or shipment of Goods after the Petition Date pursuant to an outstanding order will render such Vendors unsecured creditors of the Debtors' estates.

6. Accordingly, Vendors may decline to ship, or may instruct their suppliers not to deliver Goods destined for the Debtors unless the Debtors issue substitute purchase orders postpetition or obtain a Court order confirming that all obligations of the Debtors arising from outstanding orders, delivery of which occurs postpetition, are to be granted administrative expense status pursuant to Section 503(b)(1)(A) of the Bankruptcy Code. For each Debtor to reissue all of the outstanding purchase orders would require a significant investment of the Debtors' resources and would divert the attention of a significant number of critical employees from the Debtors' reorganization efforts. Additionally, the potential delay in receiving Goods that would be caused by having to reissue purchase orders could significantly disrupt the Debtors' operations and reorganization efforts.

7. Pursuant to Section 503(b)(1)(A) of the Bankruptcy Code, all obligations that arise in connection with the postpetition delivery of goods to the Debtor are, by definition, administrative expenses. 11 U.S.C. § 503(b)(1)(A). Although the Debtors believe that they therefore have the authority to make payment for such Goods received postpetition (irrespective of the time the purchase orders were first placed), confirmation of that authority is, in the Debtors' view, highly desirable. The Debtors' relationship with their Vendors is important and it is therefore important to reassure the Vendors that their valid claims will be given administrative expense priority status, and that they will be paid by the Debtors in the ordinary course of business for Goods delivered postpetition.
