**ORDER GRANTING EMERGENCY MOTION FOR ENTRY OF  
AN ORDER PURSUANT TO BANKRUPTCY RULE 1015(b)  
DIRECTING JOINT ADMINISTRATION OF CASES**

Upon the Emergency Motion for Entry of an Order Pursuant to Bankruptcy Rule 1015(b) Directing Joint Administration of Cases (“Motion”) filed by the above-captioned debtors and debtors in possession (collectively, the “Debtors”), and the Court having jurisdiction to consider the Motion, having heard the evidence and statements of counsel regarding the Motion, and finding that no further notice is needed, it is therefore

**ORDERED**, that the Motion is GRANTED; and it is further

**ORDERED**, that all capitalized terms not defined herein shall have the meaning given to them in the Motion; and it is further

**ORDERED**, that there shall be joint administration of the above-captioned Chapter 11 cases, which shall be jointly administered for administrative purposes only under Case Number

**ORDERED**, that the following jointly administered caption shall be used for pleadings filed in the above-referenced cases:

**ORDERED**, that this Court shall retain jurisdiction over all matters arising from or related to the interpretation and implementation of this Order.
