Supplement to Proof of Claim Filed by Citrix Systems Inc.

Citrix Systems Inc. (“Claimant”) submits this supplement to its proof of claim with regard to the chapter 11 case of Gold’s Gym Franchising, LLC, Case No. 20-31322, against debtor Golds Gym Franchising, LLC (“Debtor”).

On May 4, 2020 (the “Petition Date”), Debtor and certain of its affiliates (collectively, the “Debtors”) filed voluntary petitions under chapter 11 of the Bankruptcy Code. Prior to the Petition Date, Claimant provided software licensing services to the Debtors for which it has not been paid, as evidenced by the invoice attached hereto as **Exhibit A** and the purchase order attached hereto as **Exhibit B**.

Claimant reserves the right to (a) amend and/or supplement this Proof of Claim at any time, including after the applicable bar date, and in any manner; (b) to file additional proofs of claim for any additional claim(s) that may be based on the same or additional documents or grounds of liability; and (c) assert this Proof of Claim against a different debtor entity that may be responsible for the indebtedness. This Proof of Claim is not, and shall not be deemed to be, a waiver of any claim by Claimant.

The filing of this Proof of Claim is not and shall not be deemed or construed as (a) a waiver or release by Claimant of any rights against any person, entity or property; (b) a consent by Claimant to the jurisdiction of any court with respect to proceedings, if any, commenced in any case otherwise involving Claimant; (c) a waiver or release of Claimant’s right to trial by jury, or Claimant’s consent to trial by jury in this Court or any other court in any proceeding as to any and all matters so triable herein, whether or not the same be designated legal or private rights or in any case, controversy or proceeding related thereto, notwithstanding the designation or not of such matters as core proceedings pursuant to 28 U.S.C. § 157 or otherwise; (d) a waiver or release of Claimant’s right to have, or to assert that, any and all final orders in any and all matters or proceedings be entered only after *de novo* review by a judge of the United States District Court; (e) a waiver of the right to move to withdraw the reference with respect to the subject matter of this Proof of Claim, any objection thereto or other proceeding which may be commenced in this case or otherwise involving Claimant; (f) an election of remedies or choice of law; (g) a waiver or release of or any other limitation on Claimant’s right to assert that any portion of the claims asserted herein are entitled to treatment as priority claims or as administrative claims under §§ 503(b) and 507(a) of the Bankruptcy Code; or (h) a waiver of any rights, claims, actions or defenses, setoffs, recoupments or other matters to which Claimant is entitled under any agreements, at law, in equity or otherwise.


