Claims

6. The Debtors are indebted and obligated to the Claimants in a contingent and unliquidated amount with respect to any and all rights and entitlements that the Claimants have or may have to indemnification, contribution, reimbursement or other payments (e.g., including, without limitation, damages, costs, director fees, expense reimbursements, and expenses related thereto) from the Debtors pursuant to applicable law, contract, or otherwise arising in respect of or by reason of claims, cross-claims, or counter-claims, including, without limitation, avoidance actions that may be brought pursuant to sections 554, 547, 548, 549, and 553 of title 11 of the

- 12. Solely to the extent that the value, within the meaning of section 506(a) of the Bankruptcy Code, of any property securing the Claims and/or the Setoff Rights, if any, is less than the allowed amount of the Claims, the Claims may be treated, in part, as general unsecured
