ATTACHMENT TO PROOF OF CLAIM

By the attached Proof of Claim, Evince Communications, LLC (“Evince”) seeks payment of management fees due under an agreement between Evince and Graceway Pharmaceuticals, LLC (the “Debtor”) in the amount of \$23,040, and “honoraria” totaling \$57,637.67 for services provided to the Debtor by certain speakers (the “Speakers”). Although the Debtor’s obligation for these honoraria is to each Speaker, Evince has in the past received these payments from the Debtor on behalf of the Speakers, and then passed on such payments to those Speakers. Although Evince does not believe it has any contractual obligation to seek payment on behalf of these Speakers, it is doing so to ensure that the Speakers do not inadvertently forfeit any of their substantive rights. The amount requested is net of post-petition payments which Evince has already received from the Debtor. Documentation supporting these claims is available upon request.
