During that time, on behalf of the Debtors, EWP has prepared and prosecuted numerous patents to issuance by the United States Patent Office and other patent offices throughout the world. In addition, EWP provided legal services by way of enforcement of Debtors' patents in an effort to avoid abandonment, loss of rights, in and to the Debtors' respective patents, all in an effort to maximize the value of the Debtors' assets.

As a compliment to providing legal services, EWP has expended significant sums by way of third party expenditures. A more complete recitation of EWP's services and expenditures on behalf of the Debtors is found in the *Debtors' Application for an Order Pursuant to 11 U.S.C. Section 327(e) of the Bankruptcy Code Authorizing the Debtors to Retain and Employ Edwards Wildman Palmer LLP as Special Intellectual Property Counsel for the Debtors Nunc Pro Tunc to the Petition Date (the "Retention Application")*, filed in these cases on October 21, 2011 [Dkt. No. 149].<sup>2</sup>

#### b. Secured Claim

#### c. Proof of Claim

For the period preceding the Petition Date, EWP is owed approximately \$201,722.90 in fees and \$13,353.27<sup>3</sup> in expenses, for a total pre-petition amount due and owing of \$215,076.17.


