**Debtor**

A Debtor is the person, corporation, or other entity that has filed a bankruptcy case.

Certain of the Debtors were known by other names within the past six years; such former names are identified in the notice of commencement.

**Creditor**

A creditor is the person, corporation, or other entity owed a debt by the Debtor on the date of the bankruptcy filing.

**Claim**

A claim is the creditor's right to receive payment on a debt owed by the Debtor that arose on the date of the bankruptcy filing. See 11 U.S.C. § 101(5). A claim may be secured or unsecured.

**Proof of Claim**

A proof of claim is a form used by the creditor to indicate the amount of the debt owed by the Debtor on the date of the bankruptcy filing. The creditor must file the form with The Garden City Group, Inc. as described in the instructions above.

**Secured Claim Under 11 U.S.C. § 506(a)**

A secured claim is one backed by a lien on property of the Debtor. The claim is secured so long as the creditor has the right to be paid from the property prior to other creditors. The amount of the secured claim cannot exceed the value of the property. Any amount owed to the creditor in excess of the value of the property is an unsecured claim. Examples of liens on property include a mortgage on real estate or a security interest in a car. A lien may be voluntarily granted by a Debtor or may be obtained through a court proceeding. In some states, a court judgment is a lien. A claim also may be secured if the creditor owes the Debtor money (has a right to setoff).

**Section 503(b)(9) Claim**

A Section 503(b)(9) claim is a claim for the value of any goods received by the Debtor within 20 days before the date of commencement of a bankruptcy case in which the goods have been sold to the Debtor in the ordinary course of such Debtor's business.

**Unsecured Claim**

An unsecured claim is one that does not meet the requirements of a secured claim. A claim may be partly unsecured if the amount of the claim exceeds the value of the property on which the creditor has a lien.

**Claim Entitled to Priority Under 11 U.S.C. § 507(a)**

Priority claims are certain categories of unsecured claims that are paid from the available money or property in a bankruptcy case before other unsecured claims.

**Redacted**

A document has been redacted when the person filing it has masked, edited out, or otherwise deleted, certain information. A creditor should redact and use only the last four digits of any social-security, individual's tax-identification, or financial-account number, all but the initials of a minor's name and only the year of any person's date of birth.

**Evidence of Perfection**

Evidence of perfection may include a mortgage, lien, certificate of title, financing statement, or other document showing that the lien has been filed or recorded.

**Offers to Purchase a Claim**

Certain entities are in the business of purchasing claims for an amount less than the face value of the claims. One or more of these entities may contact the creditor and offer to purchase the claim. Some of the written communications from these entities may easily be confused with official court documentation or communications from the Debtor. These entities do not represent the bankruptcy court or the Debtor. The creditor has no obligation to sell its claim. However, if the creditor decides to sell its claim, any transfer of such claim is subject to FRBP 3001(e), any applicable provisions of the Bankruptcy Code (11 U.S.C. § 101 et seq.), and any applicable orders of the bankruptcy court.

*In re Graceway Pharmaceuticals, LLC* (the "Debtor")  
*Bankr. D. Del. No. 11-13036*

Ropes & Gray LLP ("R&G") asserts a claim in the amount of \$431,627.66 (the "Prepetition Fees"), for prepetition legal services performed for the Debtor in representing the Debtor in the civil action styled *Graceway Pharmaceuticals, LLC and 3M Innovative Properties Co. v. Fougere Pharmaceuticals Inc. f/k/a Nycomed US Inc.*, Civil Action No. 10-937-WJM-MF (D. N.J.) (the "Patent Action").

Specifically, R&G services were rendered in connection with patent infringement claims by the Debtor against the defendant. Accordingly, under New York, Massachusetts and any other relevant law, R&G has an attorney's lien for the Prepetition Fees.

R&G therefore asserts a secured claim in respect of the Prepetition Fees, secured as of the Petition Date by the Patent Action and any proceeds thereof. The Patent Action has been sold pursuant to order of the Bankruptcy Court, free and clear of liens. The amount of proceeds of such sale in respect of the Patent Action exceeds the amount of the Prepetition Fees. Thus R&G's attorney's lien now attaches to the proceeds of such sale. R&G's lien is senior in priority to the lien of the Administrative Agent and any lenders.

R&G also asserts a general unsecured deficiency claim to the extent that any of its secured claim is not allowed, whether on grounds of valuation of the collateral or otherwise.

In order to maintain the attorney-client privilege, R&G has not attached copies of its invoice, or time records, supporting the Prepetition Fees. Such documentation is available upon request by the Debtor.
