The undersigned hereby certifies that, as of the date hereof, no answer, objection or other responsive pleading has been received to the **Third Monthly Application of Alvarez & Marsal North America, LLC as Restructuring Advisors for the Debtors and Debtors-in-Possession for Allowance of Compensation and Reimbursement of Expenses Incurred for the Interim Period December 1, 2011 through December 31, 2011** [Docket No. 458] (the "Application").
