Dear Judge Walsh,

This is in response to the protest letter sent to me February 2012, regarding the bankruptcy of Graceway Pharmaceuticals, LLC, Case No. 11-13036.

In May of 2011, I was asked to give 2 promotional talks/lectures on Zyclara, a medication owned and marketed by Graceway. Graceway arranged these lectures, and their drug representative was present at both meetings.

I gave these 2 lectures in Columbia, SC and Greenville, SC in May 2011. I was asked to make my own travel arrangements and pay for them as well (which I did), with the clear understanding that Graceway would reimburse me for these expenses and pay the honoraria, of \$2000 for each lecture (\$4000 total).

The travel expenses were for flights to South Carolina, transportation, hotel expenses, food, and return flight home, totaling \$1600, for a total of \$5600.

I have been asked to speak on Graceway's behalf, for the same medication, in the same type of venue many times in the past, and have always been reimbursed promptly, by Graceway, for these types of events. These events (and expenses) took place in May of 2011. I asked to be reimbursed on multiple occasions, but heard nothing from Graceway until October 2011 when they filed for bankruptcy.
