**MCKESSON CORPORATION’S JOINDER TO LIMITED OBJECTION OF
CARDINAL HEALTH INC. TO CONFIRMATION OF THE DEBTORS’ AMENDED
CHAPTER 11 PLAN OF LIQUIDATION AND RESERVATION OF RIGHTS**

McKesson Corporation, on behalf of itself and its divisions, subsidiaries and affiliates, (collectively, “McKesson”), by and through its undersigned counsel, hereby joins the Limited Objection of Cardinal Health to Confirmation of the Debtors’ Amended Chapter 11 Plan of Liquidation and Reservation of Rights [Docket No. 657] (“Cardinal Objection”).
