**LIQUIDATING TRUSTEE'S STATEMENT WITH RESPECT TO VALUATION OF
THE TRUST ASSETS AS OF MAY 4, 2012, THE EFFECTIVE DATE**

Kip Horton ("Trustee"), the Liquidating Trustee, appointed under that certain Graceway Liquidating Trust ("Trust") Liquidating Trust Agreement ("Trust Agreement"), dated May 4, 2012 and pursuant to the Debtors' First Amended Joint Plan of Liquidation ("Plan") [D.I. 551], confirmed by entry of the confirmation order on April 20, 2012 [D.I. 722], hereby files his estimate of the value of the Trust Assets as of the Effective Date¹ in accordance with section 2.9 of the Trust Agreement ("Valuation").

This valuation does not purport to represent financial statements prepared in accordance with Generally Accepted Accounting Principles ("GAAP"), nor is it intended to be reconciled with the financial statements of the Debtors. The valuation contains unaudited information that is subject to further review and potential adjustment. It reflects the Trustee's reasonable best efforts to report the value of the Trust Assets as of the Effective Date.

In preparing the Valuation, the Trustee relied on financial data derived from the books and records of the Debtors and information from the Canadian Receiver for Graceway Canada. Although the Trustee has made reasonable efforts to ensure the accuracy and completeness of the

Note: Distribution from Graceway Canada is an estimate of the net proceeds after taxes. The actual amount realized and available for distribution to creditors is at this time still undetermined. The amount includes cash on hand and the proceeds from a pending tax refund.

The value of the Piney Flats distribution center reflects Debtors' management's estimated fair market value of the facility, and the value to which it was recorded in the books and records of the Debtors. It is currently listed for sale with a broker with an asking price of \$1,999,999. The Trustee has not commissioned an appraisal for the property and, therefore, has insufficient knowledge to challenge management's business judgment at this time. The Trustee has requested that the broker provide data on comparable properties so that an assessment of current market value can be made.



No estimate has been made for preference recoveries due to the uncertainty associated with such actions.
