**Gulf Packaging, Inc's first omnibus objection to priority claims pursuant to Fed. R.
Bankr.P.3007(D)(8)**

I appose the objection to reclassify my priority claim as general unsecured claims for the following reasons:

1. I worked for Gulf Packaging Inc as a Packaging specialist, as stated on my business cards provided by Gulf Packaging Inc. My phone, expenses, and office were all provided by Gulf Packaging Inc. My duties, work schedule and all other aspects of my employment were all determined by Gulf Packaging Inc. According to the Texas Employment Commission that makes me a Gulf Packaging Employee.

2. ADP simply provided human resource services to Gulf Employees. I have included copies of ADP documents stating that I was a Gulf employee.

3. I worked as a Packaging Specialist for Gulf Packaging Inc. on a commission basis and was due \$16,325.36 in commissions at the time of resignation on 3-3-15.

I have enclosed a copies of e-mails from Jeff Cutshall and Carol Cutshall to confirm this claim. Both emails state that I will be receiving my final commission checks from Gulf Packaging Inc., not from ADP.

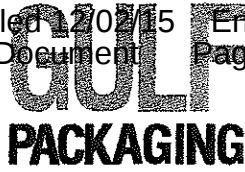

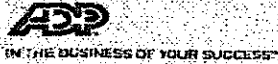
