**NOTICE OF CREDITOR TRUSTEE’S
SETTLEMENT WITH AUTOMATED PACKAGING SYSTEMS, INC.**

PLEASE TAKE NOTICE that Joseph Myers, not individually but solely as trustee (the “*Creditor Trustee*”) of the Gulf Packaging, Inc. Creditor Trust (the “*Creditor Trust*”), and Automated Packaging Systems, Inc. (the “*Automated*”) have reached a settlement pursuant to the terms of the Settlement Agreement attached hereto as Exhibit A.

NOTICE IS FURTHER GIVEN THAT, pursuant to Section III of the Order Granting Motion to Establish Procedures Governing Adversary Procedures (the “*Adversary Procedures Order*”) [ECF No. 385]² entered on April 12, 2016, any party that wishes to object to the above-referenced settlement must, within fourteen (14) days of the service of this Notice, file a written objection to the proposed settlement with the Court **and** serve such objection on: (i) counsel for the Creditor Trustee, Freeborn & Peters LLP, Attn: Elizabeth L. Brookner, Esq., 1601 Elm Street, Suite 4600, Dallas, TX 75201; (iv) counsel for FCC, LLC, Goldberg Kohn Ltd., Attn. Dimitri G. Karcazes, Esq., 55 East Monroe Street, Suite 3300, Chicago, IL 60603; and (v) the Office of the United States Trustee.

NOTICE IS FURTHER GIVEN THAT, if no objections are timely filed to the proposed settlement, a hearing will not be held, and the Creditor Trustee will file a Certificate of No Objection (“*CNO*”) with the Court attaching a proposed order approving the settlement agreement, and the Court may enter the proposed order without any further notice or hearing.

In the event that a person objects to the proposed settlement in the manner proscribed above, the Court will address the proposed settlement and objection at the next Omnibus Hearing.
