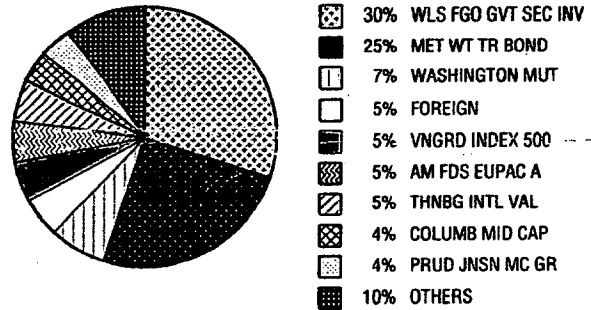

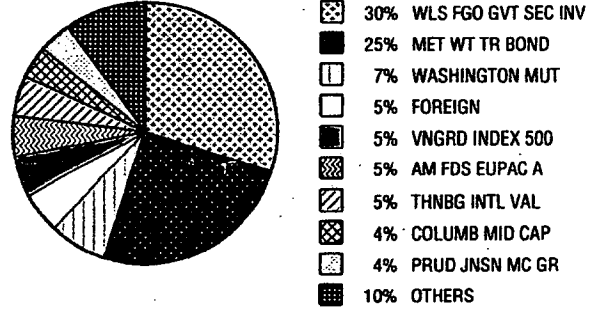

### Your Fund Allocation Profile

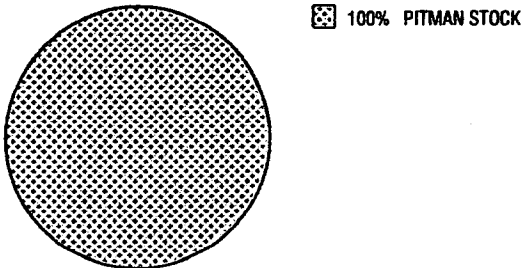
#### PROFIT SHARING Existing Balance Allocation



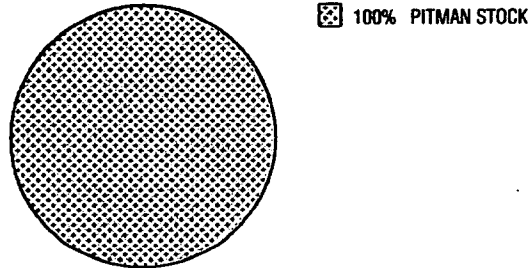
#### PROFIT SHARING Current Investment Election
