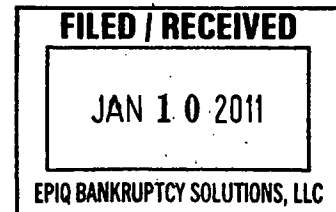

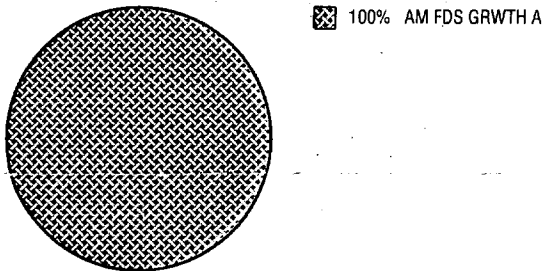

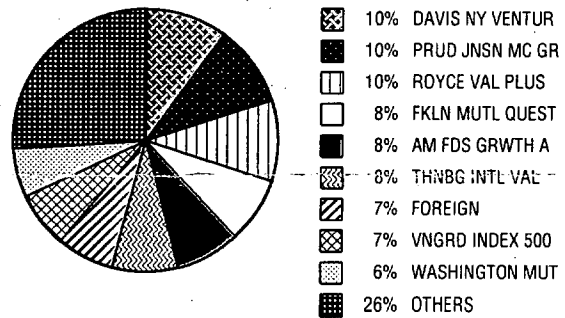

401(k) Current Investment Election



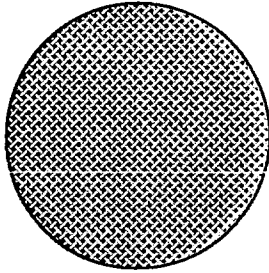

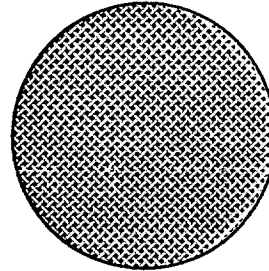
Your Fund Allocation Profile
