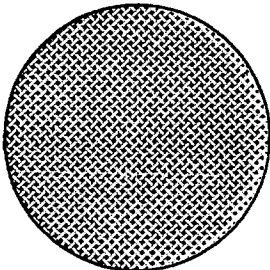

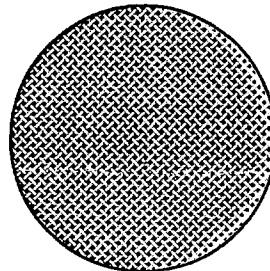
Your Fund Allocation Profile

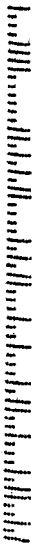

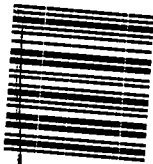
