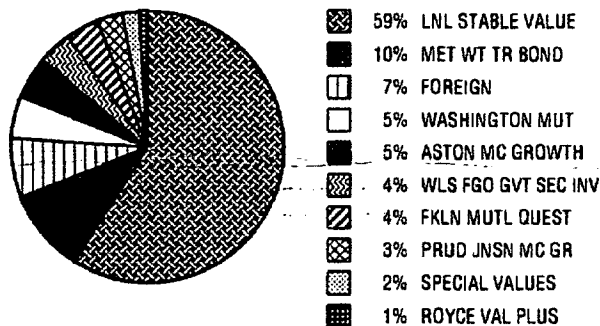

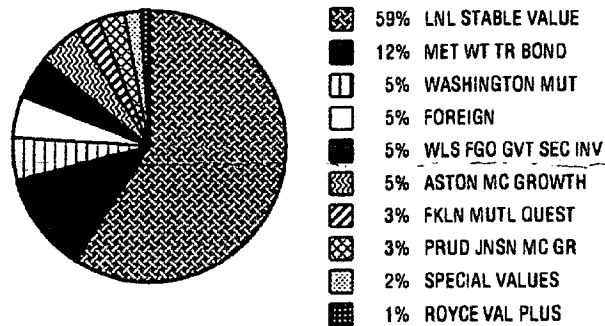

### 401(k) Current Investment Election

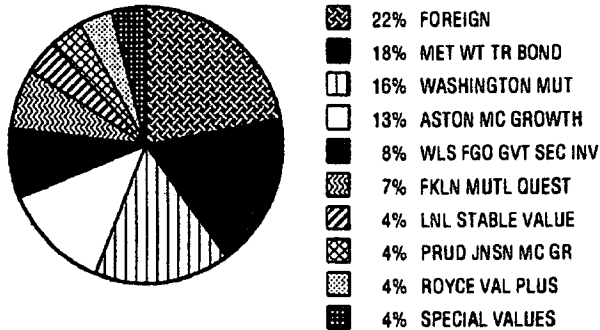

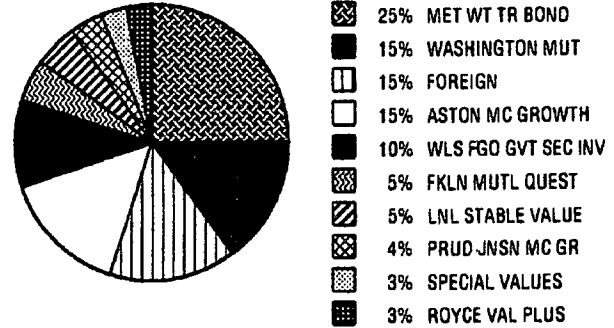
