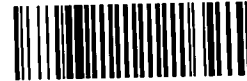

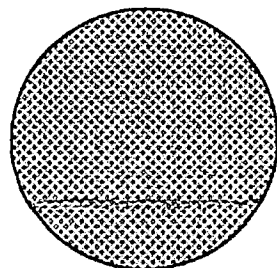

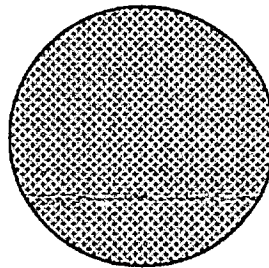
Your Fund Allocation Profile
