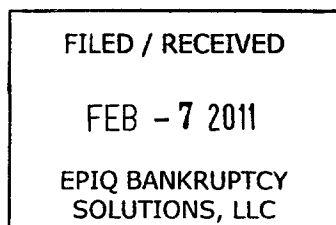
2. The debtor herein was, at the time of the filing of the petition initiating this case, and still is, indebted to this claimant in the sum of **\$429.29**.


