

**ATTACHMENT TO PROOF OF CLAIM  
OF ACUITY, A MUTUAL INSURANCE COMPANY**

Acuity, a Mutual Insurance Company (“Acuity”) submits its proof of claim in the bankruptcy proceedings of Debtor Belvidere Associates LLC (“Debtor”) as a priority claim pursuant to 11 U.S.C. § 507(a)(2). The claim is entitled to an administrative priority, under 11 U.S.C. § 507(a)(2) and 11 U.S.C. § 503(b), as a result of the claim being for post-petition insurance premiums which were actual and necessary costs for preserving the Chapter 11 estate of Debtor.

Debtor did not list Acuity as a creditor on Debtor’s bankruptcy schedules or mailing matrix. Acuity did not learn of Debtor’s bankruptcy until July of 2019, which was after the date set for the filing of claims in these proceedings. Accordingly, Acuity could not have filed its proof of claim in time to meet the Bankruptcy Court’s fixed deadlines. As a result of Acuity not receiving any notice of the debtor’s bankruptcy, Acuity’s proof of claim should be treated as having been timely filed pursuant to Bankruptcy Rule 3002(c)

The claim of Acuity, in the amount of \$75,588.17 should be allowed in its entirety as a timely-filed administrative priority claim.
