ADDENDUM TO PROOF OF CLAIM

Moreover, the execution and filing of this Proof of Claim is not and shall not be deemed: (i) a waiver of any rights or remedies available to the Claimant; (ii) a waiver or release of the Claimant’s rights against any other entity or person liable for all or any part of their claims against the Debtors; or (iii) an election of remedies that waives or otherwise affects any other remedy.
