

Acuity, a Mutual Insurance Company (“Acuity”) submits its proof of claim in the bankruptcy proceedings of Debtor KLS Acquisition Corp. (“Debtor”) as a priority claim pursuant to 11 U.S.C. § 507(a)(2). The claim is entitled to an administrative priority, under 11 U.S.C. § 507(a)(2) and 11 U.S.C. § 503(b), as a result of the claim being for post-petition insurance premiums which were actual and necessary costs for preserving the Chapter 11 estate of Debtor.
